

Minimum Size 063

Initialize program. **XEQ STOCK**

Key in number of groups of historical
data. **R/S**

Key in number of shares in group n. **R/S**

Key in price per share. **R/S**

Repeat previous two steps until each stock is
entered.

To correct historical data. **E**

To delete a group. **D**

Input group number to be deleted. **R/S**

To add a group. **C**

To load current data. **B**

Key in current price. **R/S**

Key in beta coefficient. **R/S**

Key in dividend per share; press **R/S** to cal-
culate % change.

Press **R/S** to load current data for next stock.

To prepare summary and display historical port-
folio value. **0 A**

Calculate current value. **R/S**

Calculate % change in value. **R/S**

Key in interest charged on margin account (if applicable). **R/S**

Key in number of shares purchased. **R/S**
(**A**)

Key in stock price. **R/S** (**B**)

Key in dividends per share. **R/S**

Key in stock commission (%). **R/S**

Key in additional flat fee. **R/S**

Key in option exercise price. **R/S** (**C**)

Key in option premium **R/S**

Key in number of days to expiration. **R/S**

Routines for Option Writers

Minimum Size 015

Initialize program. **XEQ** **OPTION**

Answer display prompts by keying in stock price, strike price, interest rate, stock dividend, and days to expiration with **R/S**.

Key in volatility and press **R/S** to calculate theoretical value.

Calculate hedge ratio. **R/S**

Calculate number of options to write per 100.
R/S

Calculate maximum yield. **R/S**

Calculate cash flow yield. **R/S**

Calculate annualized return. **R/S**

Calculate high and low break-even points.
R/S **R/S**

Calculate point of maximum profit. **R/S**

Warrant and Option Hedging

Minimum Size 012

Initialize program. **XEQ HEDGING**

Answer display prompts by keying in annual dividend, days to expiration, stock price, warrant price, convertible price, convertible rate, margin percentage rate (%), and margin interest rate (%) with **R/S**.

Calculate maximum return (%). **R/S**

Calculate low break-even point. **R/S**

Calculate upper break-even point. **R/S**

Repeat calculations by pressing **C** for each additional warrant sold.

Press **R/S** to continue.

Key in expiration price and press **R/S** to calculate annual return.

Press **R/S** to prompt for another price.

Bull Spread Option Strategy

Minimum Size 009

Initialize program. **XEQ BULL**

Answer display prompts by keying in number of options sold short, price of options sold short, exercise price of options sold short, number of options bought long, price of options bought long, and exercise price of options bought long with **R/S**.

Key in current stock price and press **R/S** to calculate downside break-even stock price.

Calculate percent change from current stock price to downside break-even price. **R/S**

Calculate upside break-even stock price. **R/S**

Calculate percent change from current stock price to upside break-even price.

Butterfly Options

Minimum Size 008

Initialize program. **XEQ BFLY**

Answer display prompts by keying in exercise price of lowest strike option, market price of lowest strike option, exercise price of middle strike option, market price of middle strike option, exercise price of high strike option, and market price of high strike option with **R/S**.

Key in option commission and press **R/S** to calculate maximum profit.

Calculate maximum loss. **R/S**

Calculate high break-even point. **R/S**

Calculate low break-even point. **R/S**

Convertible Security Analysis

Minimum Size 007

Initialize program. **XEO CSEC**

If convertible bond press **R/S**. Otherwise key in N and press **R/S**.

Answer display prompts by keying in convertible price, either coupon or dividend, common price and annual dividend with **R/S**.

Key in conversion ratio and press **R/S** to calculate convertible price.

Calculate anticipated stock price. **R/S**

Calculate conversion parity price. **R/S**

Calculate conversion premium percentage.

R/S

Calculate current convertible yield. **R/S**

Calculate incremental payout return. **R/S**

Convertible Bond Investment Analysis

Minimum Size 016

Initialize program. **XEO CBOND**

Key in bond conversion factor. **R/S**

Key in bond current price; press **R/S** to calculate conversion value. **R/S**

Key in stock price; press **R/S** to calculate conversion premium. **R/S**

Key in bond coupon rate; press **R/S** to calculate current yield. **R/S**

Key in current annual yield; press **R/S** to calculate dividend yield.

Press **R/S** to calculate income differential. **R/S**

Key in projected stock price; press **R/S** to calculate estimated bond price.

Press **R/S** to repeat previous step. To continue, press **R/S** without data entry.

Key in settlement date. **R/S**

Key in maturity date; press **R/S** to calculate remaining coupon periods; press **R/S** to calculate accrued interest. **R/S**

Key in yield (%); press **R/S** to calculate investment value.

Press **R/S** to repeat previous step.

Bond Speculation Using Margin

Minimum Size 009

Initialize program. **XEQ** SPEC

Answer display prompts by keying in price of bond (% of par), interest rate, expected selling price, number of months held, % margin allowed, number of days since last interest payment, and interest rate charged by broker with **R/S**.

Key in broker's fee; press **R/S** to compute dollars required for speculation.

Compute gross sale dollars. **R/S**

Compute borrowed dollars. **R/S**

Compute net profit. **R/S**

Compute percent profit. **R/S**

Compute annualized net profit. **R/S**
